Dr Gavan Griffith QC is counsel at the Australian and English bars with over 30 years seniority as a silk, holding 8 Commissions as Queen's Counsel. Following extensive commercial, constitutional and public law practice as counsel, he was appointed Solicitor-General of Australia (Australia's Second Law Officer, *ex officio* the leader of the Australian bars) from 1984 to 1997. Since 1998, continuing practice, now principally from London chambers, as counsel in commercial and public law matters and as arbitrator in commercial, investment and treaty disputes (usually as presiding tribunal member).

As Solicitor-General of Australia, pleaded some 250 constitutional, international law and other cases before the entire bench of the High Court of Australia.
